

### Vision



#### Eligibility

- Any Graduate from recognized University with a minimum aggregate of 50% marks (45% in case of SC/ST) in the qualifying examination.
- A high score in the aptitude test like GMAT/CAT/XAT/MAT/CMAT/ NMAT/ATMA or DSBS entrance test.

- National Level Entrance Exam Scores

#### Scholarships

#### Case 2: For ST/SC/OBC/BPL Card Holders

The student should have 75% throughout in 10th, 12th & Bachelor's Degree, with a valid score in CAT/MAT/XAT/NMAT/ATMA/CMAT/SNAP Entrance Exam. (>500 Marks in MAT or > 75% tile in other exams.)
